#### REGISTRATION OF ADDITIONAL SHARES AND INCORPORATION OF CERTAIN INFORMATION BY REFERENCE PURSUANT TO GENERAL INSTRUCTION E OF FORM S-8

This Registration Statement on Form S-8 (this "Registration Statement") is being filed by The RealReal, Inc., a Delaware corporation (the "Registrant") for the purpose of registering an aggregate of 9,020,291 additional shares of common stock, par value \$0.00001 per share (the "Common Stock"), comprised of:

- 4,954,409 shares of Common Stock, reserved for issuance under the Registrant's 2019 Equity Incentive Plan (the "EIP") pursuant to the provision of the EIP
  providing for automatic annual increases in the number of shares reserved for issuance under the EIP;
- 990,882 shares of Common Stock reserved for issuance under the Registrant's Employee Stock Purchase Plan, as amended and restated on February 19, 2020 (the "ESPP"), pursuant to the provision of the ESPP providing for automatic annual increases in the number of shares reserved for issuance under the ESPP;
- 1,500,000 shares of Common Stock that may be issued upon the vesting of performance-based restricted stock units (the "PSUs") that will vest in accordance with
  the terms of a Stand-Alone Performance-Based Restricted Stock Unit Award Agreement by and between the Registrant and John Koryl, as an inducement for his
  accepting employment with the Registrant;
- 1,250,000 shares of Common Stock that may be issued upon the vesting of restricted stock units (the "Koryl RSUs") that will vest in accordance with the terms of a Stand-Alone Restricted Stock Unit Award Agreement by and between the Registrant and John Koryl, as an inducement for his accepting employment with the Registrant; and
- 325,000 shares of Common Stock that may be issued upon the vesting of restricted stock units (the "Friang RSUs" and, together with the PSUs and the Koryl RSUs, the "Awards") that will vest in accordance with the terms of a Stand-Alone Restricted Stock Unit Award Agreement by and between the Registrant and Luke Friang, as an inducement for his accepting employment with the Registrant.

The Awards will be issued outside of the EIP, approved by the Registrant's board of directors and issued pursuant to the "inducement" grant exception under Nasdaq Rule 5635(c)(4), as inducements that are material to employees' entering into employment with the Registrant.

This Registration Statement hereby incorporates by reference the contents of the Registrant's earlier registration statements on Form S-8 filed with the Securities and Exchange Commission (the "Commission") on July 3, 2019 (Registration No. 333-232528), May 10, 2021 (Registration No. 333-255981) and May 10, 2022 (Registration No. 333-264837), in each case, to the extent not superseded hereby. In accordance with the instructional note to Part I of Form S-8 promulgated by the Commission, the information specified by Part I of Form S-8 has been omitted from this Registration Statement.

The RealReal, Inc., a Delaware corporation (the "<u>Company</u>"), hereby grants to the individual (the "<u>Holder</u>") named in the award notice attached hereto (the "<u>Award Notice</u>") as of the date set forth in the Award Notice (the "<u>Grant Date</u>"), an award (the "<u>Award</u>") of performance-based restricted stock units ("<u>PSUs</u>") with respect to the number of shares of the Company's common stock, par value \$0.00001 per share ("<u>Common Stock</u>"), set forth in the Award Notice, upon and subject to the restrictions, terms and conditions set forth in this Award Agreement (the Award Agreement, together with the Award Notice the "<u>Agreement</u>"). The PSUs have been granted as an "inducement" award under Nasdaq listing rules outside of the Company's existing equity compensation plans. However, the PSUs will be governed in all respects as if issued under the Company's 2019 Equity Incentive Plan, as currently in effect and as may be amended hereafter from time to time.

- 1. <u>Award Subject to Acceptance of Agreement</u>. The Award shall be null and void unless the Holder accepts this Agreement by executing the Award Notice in the space provided therefor and returning an original execution copy of the Award Notice to the Company (or electronically accepting this Agreement within the Holder's stock plan account with the Company's stock plan administrator according to the procedures then in effect).
- 2. <u>Rights as a Stockholder</u>. The Holder shall not be entitled to any privileges of ownership with respect to the shares of Common Stock subject to the Award unless and until, and only to the extent, such shares become vested pursuant to <u>Section 3</u> hereof and the Holder becomes a stockholder of record with respect to such shares. The Award includes a right to dividend equivalents equal to the value of any dividends paid on the Common Stock for which the dividend record date occurs between the Grant Date and the date the Award is settled or forfeited. Subject to vesting, each dividend equivalent entitles Holder to receive the equivalent cash value of any such dividends paid on the number of shares of Common Stock underlying the Award that are outstanding during such period. Dividend equivalents will be accrued (without interest) and will be subject to the same conditions as the shares of Common Stock to which they are attributable, including, without limitation, the vesting conditions, the provisions governing the time and form of settlement of the Award.
- 3. <u>Restriction Period and Vesting</u>.

3.1 <u>Vesting Conditions</u>. The Award shall be allocated over four tranches (each, a "<u>Tranche</u>"), with the amount of PSUs eligible to vest in each Tranche set forth on <u>Appendix A</u> hereto. Each Tranche of PSUs shall vest only if both the service-based vesting conditions and performance-based vesting conditions are achieved for such Tranche, as follows:

(a) <u>Service-Based Vesting Conditions</u>. Except as otherwise provided for in this Agreement, each Tranche shall vest based on service if, only if, the Holder is, and has been, continuously (except for any absence for vacation, leave, etc. in accordance with the Company's or its Subsidiaries' policies) (i) employed by the Company or any of its Subsidiaries, (ii) serving as a non-employee director of the Board of Directors of the Company (the "Board") or (iii) providing services to the Company or any of its Subsidiaries as an advisor or consultant, in each case, from the Vesting Commencement Date specified in the Award Notice through each applicable service condition date set forth on <u>Appendix A</u> hereto (each such date shall be referred to herein as a "<u>Service Condition</u>"). For purposes of this Agreement, "<u>Subsidiary</u>" shall have the meaning set forth in the Company's 2019 Equity Incentive Plan.

(b) <u>Performance-Based Vesting Conditions</u>. Except as otherwise provided for in this Agreement, the Award shall vest based on the Company's stock price performance over the five-year performance period (the "<u>Performance Period</u>"), with each Tranche vesting on the Company's achievement of the stock price applicable to such Tranche set forth on <u>Appendix A</u> hereto (each such stock price shall be referred to herein as a "<u>Performance Condition</u>").

#### 3.2 Change in Control; Termination of Employment.

(a) <u>Termination Other Than in Connection with a Change in Control</u>. Except as otherwise provided for in Section 3.2(b), if the Holder's employment or service with the Company terminates prior to achieving a Service Condition, all unvested PSUs shall be immediately forfeited by the Holder and cancelled by the Company.

- (b) <u>Change in Control; Termination in Connection with a Change in Control</u>.
